But finally the school provides another solution by holding lessons at school with only 1 hour of learning time and students are not allowed to leave during the learning process.

And another solution provided by the school is to hold training for teachers in improving teacher technology and information in the era 4.0. and the results of the training were very fruitful for both the teacher and the students themselves. for their students and students it will be easy to master the learning that will be given by educators and for the teachers themselves it is also easier to convey material without having to stand during the learning process (PBM). My advice for

teachers at SDN 02 Tanjung Bonai is not to be complacent by only providing video material because it could be that the students will also feel bored because only with the video but later there must be more innovation from the teacher in delivering material because we are in a very sophisticated technological age. And also keep health protocols even though we study semi-online and don't be afraid of vaccines because with that we can prevent the arrival of viruses in our bodies.

Video learning is a tool that has audio (sound) and visual motion (moving images). so video learning tools function for the beginning of information from educators to students. easy to replay videos (replay) and how to convey learning material in stages or sequentially makes viedo one of the media that can improve, motivate and attract students' expertise in understanding a material to be conveyed and videos can also make students comfortable in learning and active and learning will be achieved well. This results in video media is an efficient tool used in the learning process, especially for elementary school students who need a lot of creativity and motivation in delivering learning materials. The advantages of video media can also be owned, can meet the needs of all students who have diverse learning behaviors (audio, visual, or audio-visual), can provide direct incidents that students will definitely encounter in the community and surrounding environment such as observing interaction events, how to interact and various kinds. The advantages of video media will not personally have an impact on increasing student learning outcomes but will definitely improve student learning outcomes.
